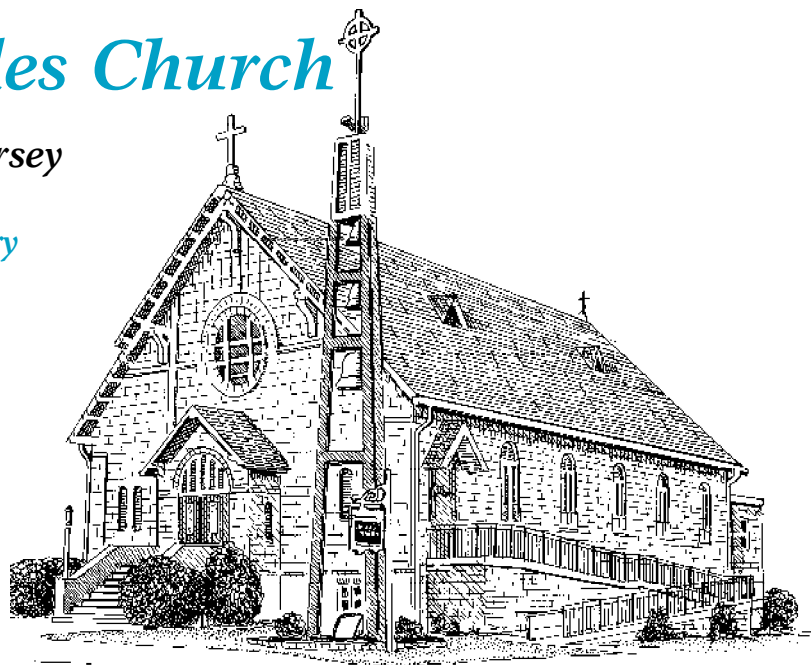

THIRD SUNDAY OF EASTER

First Reading: Acts 3:13-15, 17-19


